Paralegal/Legal Assistant Members.

A legal assistant or paralegal who meets the Oklahoma Bar Association's Minimum Qualification Standards for Legal Assistant/Paralegal dated September 15, 2000 (as it may hereinafter be amended) may become a legal assistant/paralegal member of the Corporation (TCBA) upon filing an application with the Board of Directors, together with evidence that the applicant meets at least one of the Oklahoma Bar Association's Qualification Standards, and paying the applicable dues. A legal assistant/paralegal member may not vote or hold any office of the Corporation.
